Seamless integration—Perform collection from all supported content sources directly into eDiscovery Platform.

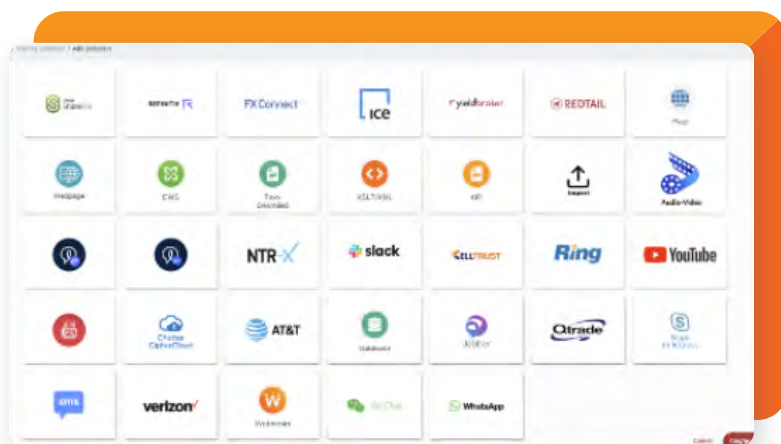
Metadata filters—Create targeted collections by filtering via metadata fields, eliminating the need for any scripting or programming.

Pre-processing analytics—Visually summarize overall document set characteristics and present detailed analysis by custodian, timeline and file type.

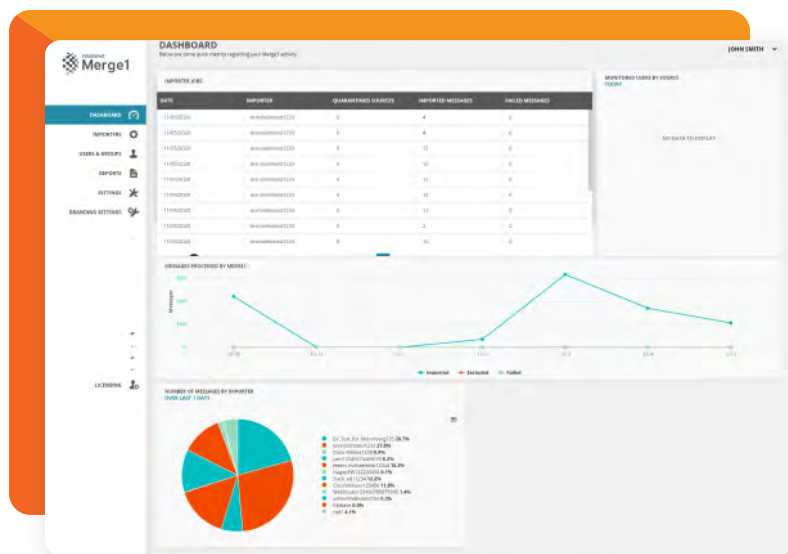
Integrated classification engine—Use classification to increase efficiency and expedite the review process.
